CIRCULAR

**Subject: Regarding online verification of applications on e-district portal in r/o State Funded Scheme "Reimbursement of Tuition fees to the Minority Students of Classes I to XII" for 2020-21 and 2021-22**

Kind attention of all Head of Private Schools are drawn to the circulars bearing No.DE. 18-(63)/PLG/2021-22/3582-3586 dated 29.04.2022 and No.DE. 18-(63)/PLG/2021-22/3634-3638 dated 09.05.2022 on the subject cited above. It is observed that there are still **heavy pendency lies at the level of school/zone as on 12<sup>th</sup> May 2022 which is adversely affecting the motto of Delhi Government regarding timely payment under the scheme to beneficiary student.**

In this regard, all DDE (Zones/Distts) are already aware that during the virtual meeting held on 10.05.2022 under the Chairmanship of Director (Education) they were directed to complete online verification of all applications on e-district portal in r/o "Reimbursement of Tuition Fees to the Minority Students" for 2020-21 and 2021-22 as per guidelines of the scheme.

In continuation of the above, all DDE(Distts/Zones) are again requested to complete online verification on e-district portal in r/o "Reimbursement of Tuition Fees to the Minority Students" for 2020-21, immediately, without further delay. Moreover, vide aforementioned circulars the said online verification was to be completed by 12.05.2022. Therefore, all are requested to complete verification at school/zonal level within stipulated time.

Further, all DDE (Zones) has to collect a certificate from concerned schools that online verification has been done as per guidelines of the scheme and also issue a certificate under their signature that they have also verified the applications at zonal level as per guidelines of the scheme (draft attached herewith). These certificates must be submitted online at [planning.branch@yahoo.com](mailto:planning.branch@yahoo.com) and via hard copy in Planning Branch, Directorate of Education at Room No. 112, 1<sup>st</sup> Floor, Old Patrachar Vidhyalaya Building, Timarpur, Delhi-110054 by 13<sup>th</sup> may 2022.

The competent authority in Revenue Deptt has informed that they will not release payment in the bank account of students of the schools which will not submit desired certificate.
